#### ADMISSION NOTICE - Ph.D. Programme

All India Institute of Medical Sciences, Raipur invites **online applications** for **Entrance Examination** for admission in Ph.D. Programme – **2024 Session** AIIMS Raipur. Relevant details of guidelines for the course may be downloaded from PhD Guidelines 2023 hosted at AIIMS, Raipur official website.

**NOTE:** A candidate is allowed to submit application for Ph.D. programme in one subject only.

#### 2. ESSENTIAL QUALIFICATION:

A candidate must possess the qualification/Eligibility criteria and degree as mentioned against the subject, for which he/she is applying by 31.08.2024. The candidates who are completing their requisite qualification/Eligibility criteria after 31.08.2024 are not eligible to take up this examination.

## A. General Eligibility Criteria For Admission Of External Candidates:

#### i. Candidates holding Medical Qualification:

Must possess a Medical degree or a Postgraduate degree in the subject concerned or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and National Medical Commission Act, 2019 or recognized by the respective regulatory bodies, and candidates who have obtained MBBS/BDS/MD/MS/MDS degree are eligible to apply.

#### ii. Candidates holding Non-Medical Qualification:

- a) Candidates who have obtained a Masters Degree in any subject recognized by UGC from the colleges/institutes recognized by the respective regulatory bodies/UGC are eligible.
- b) Candidates holding M.Sc. degree in nursing specialty will also be eligible for PhD admission.
- c) Candidate possessing Masters Degree through distant learning course shall not be eligible.

#### iii. Minimum aggregate marks to be obtained in the Qualifying Degree Examination:

Candidates who have obtained their qualifying degree scoring at least 55% marks in aggregate shall be eligible to apply for the PhD entrance examination.

## iv. Criteria for candidates already holding a PhD Degree:

Candidates who already posses a PhD Degree awarded/successfully qualified in any subject by AIIMS, Raipur/any other recognized academic institution, shall not be eligible to apply for another additional PhD degree at AIIMS, Raipur.

#### **NOTE:**

- 1. Candidates who have qualified in above said examinations leading to award of fellowships will be given special weightage in the entrance examination as detailed in method of selection part of guidelines.
- 2. Candidates working under Central Govt./Semi Govt./Autonomous organization should submit their applications through proper channel i.e. employer. They will be required to submit a 'No Objection Certificate' from their employer before they are allowed to join the Ph.D. Course.

#### E. Eligibility Criteria for Admission of In-service Candidates from AIIMS, Raipur:

- 1. Applications to be entertained only from regular AIIMS, Raipur Faculty. Also, regular non-teaching technical Staff will be considered for Ph.D. registration as in-service candidates subject to further conditions laid down as per PhD Guidelines, 2023 of AIIMS, Raipur and Central Civil Service (Conduct) Rules, 1964 in this regard.
- 2. Staff members of AIIMS, Raipur employed under various research schemes which are of tenure basis and are not permanent employees of AIIMS, Raipur are not considered as In-service / Internal candidates and must fulfil the eligibility criteria laid down for External candidates for application (vide Items 2A & 2B above and PhD Guidelines, 2023 of AIIMS, Raipur) through entrance examination.
- F. Eligibility Criteria for Deputed / Sponsored Candidates and Foreign Nationals/Overseas Citizen of India:

As per conditions laid down vide Items 6 & 7 of PhD Guidelines, 2023, AIIMS, Raipur in addition to Note 2 above.

#### 3. **DURATION OF COURSE:**

- i. The duration of the course shall be the time period from registration to submission of thesis/dissertation. The minimum period of registration in respect of all the candidates who are registered for Ph.D. shall be three years i.e. the thesis cannot be submitted before three years. The maximum period of registration shall not exceed five years. Extension beyond the period of 5 years can be given for a maximum period of 6 months on the recommendation of Doctoral Committee and final approval by Dean (Academics)/Director.
- **ii.** Further extension beyond 5 years & 6 months can only be given by the Academic Committee for a maximum period of 6 months in highly exceptional circumstances (like medical exigencies, natural calamities etc.) and such extension may not be given retrospectively.
- **iii.** The Chief guide of Ph.D. Student shall give clear reason for the delay to the Academic Committee and must present the case before Academic Committee.
- **iv.** In case of extension beyond 6 years without justifiable reasons and circumstances as mentioned above, the PhD registration of the candidate shall be cancelled.

v. Failure to submit thesis within stipulated time period of maximum 5yrs. with extension after approval upto 5½ years (6 years in exceptional circumstances by prior approval of Academic Committee) shall lead to cancellation of PhD registration of the candidate.

#### 6. METHOD OF SELECTION FOR EXTERNAL CANDIDATES:

Selection for Ph.D. registration will be through a two-stage performance evaluation as under:

I. Stage I: 40 Marks (40 MCQs of 1 Mark each): Aptitude related MCQs covering English (Written and verbal skills), Biostatistics, Research Methodology, etc.

**Stage II: 50 Marks** (50 MCQs of 1 Mark each): Subject related theory based Multiple Choice Questions (MCQs) mainly exploring broad based basic scientific knowledge and particularly analytical aptitude for research in the subject.

**Total Marks (Stage I + II)** : 90 (40+50) marks

**Total Duration (Stage I + II):** 90 Minutes

Candidates must score at least 45 marks in stages I and II (combined) to be eligible for selection.

- **II.** The Special Weightage of 10 marks will be added to the total score of Stages I and II for candidates who fulfil either of the following criteria:
  - Any Candidate who have qualified in any one of the following entrance tests in the last 2 years: Joint CSIR-UGC NET for JRF, ICMR-JRF, ICMR-SRF, DBT-JRF, DBT-SRF, NBHM screening test, Graduate aptitude test (GATE), INSPIRE fellowship, UGC-JRF, UGC-SRF, CSIR-JRF, CSIR-SRF, DST-JRF, DST-SRF or are sponsored/deputed candidates.

#### III. EVALUATION PROCEDURE FOR STAGE I AND STAGE II

Each correct (MCQ) answer will be awarded 1 mark. There will be no negative marking. More than one answer, overwriting, correction, questions not answered or marked for review will be treated as wrong answer.

If any discrepancy in any question is found in the Entrance Examination, the candidate is advised to write to AIIMS Raipur within 24 hours of completion of examination on the following email: <a href="mailto:examsection@aiimsraipur.edu.in">examsection@aiimsraipur.edu.in</a>.

#### Note:

- I) The combined result of stage-I, stage-II for Ph.D. Courses will be available on website of AIIMS Raipur (<a href="www.aiimsraipur.edu.in">www.aiimsraipur.edu.in</a>). No individual intimation will be communicated to the candidate.
- II) Candidates who fail to attend any of the stages of examinations as mentioned above will not be eligible for admission.
- III) Admission to Ph.D. Course will be subject to the availability of research funds/fellowship/grant/stipend from AIIMS, Raipur/recognized fund in agencies.

After declaration of results, selection letters will be issued by the Academic Section only to those candidates who have submitted Undertaking/Certificate proof of their funding sources through concerned Head of the Departments. This shall be in case of candidates who obtain any funding other than stipend from AIIMS, Raipur.

#### IV. METHOD OF RESOLVING TIES FOR SELECTION OF EXTERNAL CANDIDATES:

#### For Medical Candidates:

If two or more candidates obtained equal marks in the entrance examination, their inter-se-merit for selection shall be determined on the basis of the following:

- a) Candidate who has made more attempts in passing the various professional MD/MS/DNB/MDS/MBS/BDS examination shall rank junior to the candidate who has made lesser attempts.
- b) If the attempts made in passing MD/MS/DNB/MDS/MBS/BDS professional examinations are also the same, then a candidate who has obtained higher marks in the qualification examination shall rank senior to a candidate who has obtained lower marks. In case any candidate has not filled up the aggregate marks in the application form showing the percentage of aggregate marks in MBBS/BDS, he/she will rank junior to other candidate in inter-se-merit.
- c) If the attempts made in passing MD/MS/DNB/MDS/MBS/BDS professional examination as also the marks obtained in qualifying examination are the same, then a candidate senior in age shall rank senior to the candidate who is junior in age.

A "Failure" in the examination or "Re-appear" in the examination will constitute an attempt.

#### For Non Medical Candidates:

If two or more candidates obtain equal marks in the entrance examination for admission to Ph. D. then their inter-se-merit for admission to the course shall be determined on the basis of the following:

- a) Candidate who has made more attempts in passing Post-graduate examination would rank junior to the candidate who has made lesser attempts.
- b) If attempts made in passing of Post-graduate examination are also the same, then candidate who has obtained higher marks in the Post-graduate examination will rank senior to a candidate who obtained lesser marks.

c) If attempts made in passing Post-graduate examination and the marks obtained in Post-graduate examination are also the same, then the candidate senior in age shall rank senior to the candidate junior in age.

#### V. DOCUMENT VERIFICATION:

Based on the marks secured in the entrance examination selected candidate will undergo scrutiny for the verification of the documents and final selected list of the candidates will be prepared accordingly subject to fulfilling the eligibility in all terms described in the eligibility criteria mentioned the clause 2 of the advertisement.

After the entrance examination provisional selection list will be published in the AIIMS Raipur website i.e. www.aiimsraipur.edu.in.

#### VI. METHOD OF SELECTION FOR IN-HOUSE CANDIDATES FROM AIMS, RAIPUR:

The candidate shall be exempted from appearing in the PhD entrance examination and his/her candidature will be considered upon fulfilling the conditions laid down under Item 5 of PhD Guidelines, 2023 of AIIMS, Raipur.

#### VII. MEDICAL EXAMINATION:

Medical fitness will be a pre-condition for registration of all candidates. The candidates will be medically examined by a Medical Board, constituted by the Institute for this purpose to determine their medical fitness.

#### VIII. JOINING:

Selected candidates are required to join before 15.07.2024. The competent authority may permit an extension of joining till 31.07.2024 based on merit of each case. In case the candidate fails to join by this date and no written request for extension is received by 31.07.2024, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list.

Last date for admission to the course will be 31.08.2024 In any circumstances, last date for admission will not be extended after 31.08.2024. This includes candidates on the wait list who may be offered a seat if the selected candidates does not join. Apart from In-house candidate, the PhD courses can be joined only as full time courses after getting relieving letter from sponsoring agency.

**Note 2:** Fees and other charges including hostel rent once paid shall not be refunded in any case and no correspondence will be entertained in this connection. However, the caution money will be refunded to those candidates who do not join the course. The caution money must be claimed within one year after completion of the course failing which it will be forfeited.

# Fees for Foreign Nationals / Self financed nominees / candidates and similar designations of Indian Government:

US Dollar 75,000/- inclusive of all Items mentioned in (i) above for the entire course, to be paid in three equal installments of USD 25,000/- each with a maximum gap of one year between payment of each installment. Permission to write the thesis shall be subject to full payment of the fees.

#### AGREEMENT BOND/SURETIES/CONTRACT

Any candidate, who joins Ph.D. programme and leaves the course, will be required to refund the fellowship/ stipend amount, if any, paid to the candidate and forfeiture of the security deposited by the candidates in addition to payment of an amount of Indian Rs.3,00,000/- as penalty. Towards this effect, the candidate will be required to submit bond on non-judicial paper of Rs.100/- in the prescribed format at tested by the Notary valid for a period of five years at the time of joining the course.

#### **HOSTEL ACCOMMODATION:**

The unmarried Ph.D. students will be provided partially furnished accommodation subject to availability. Those married and living with family will be provided, subject to availability, partially furnished married hostel accommodation on recovery of rent as per rules of AIIMS Raipur. However, the sponsored Ph.D. students will be charged a sum of Rs.450/- per month for single room hostel accommodation and a sum of Rs.650/-per month for married hostel accommodation.

#### 8. HOW TO APPLY:

- (A) Candidate may access the online application by clicking on the link mentioned in the website (www.aiimsraipur.edu.in).
- (B) Applicants must fill all the fields <u>carefully</u> since after submission of online application request for change in any information at any later stage will <u>not</u> be considered.
- (C) The candidates are requested to fill the correct details regarding name/age/sex/caste/address/educational qualification and other relevant fields mentioned in the application.

#### 9. APPLICATION FEE AND MODE OF PAYMENT:

#### **Mode of Payment: Through Online**

- General / OBC Category: Rs.1500/- + Transaction Charges as applicable
- SC/ST Category: Rs.1200/- + Transaction Charges as applicable
- PWBD Candidates is exempted from application fee

For all purposes for candidate applying under SC/ST/OBC(NCL)/EWS/ & PWBD category, the candidate must possess a certificate issued by competent authority (as applicable to category/format provided by AIIMS Raipur) within one year of last date for Online Registration 02.06.2024 (i.e. issued between 01.06.2023 to 02.06.2024).

Application fee is required to be remitted **online** only. Any other instrument of payment is not acceptable. Please make sure that the confirmation of the successful remittance by your bank and retain the proof of the same which may be required at the time of document verification. The application fee is non-refundable.

- (A) Candidates may please note that unless they make the payment of Application Fee, their application will be treated as INCOMPLETE.
- (B) **Payment of fee:** Candidates can pay the application fee through **ONLINE**. Additional charges viz. bank charges, service tax etc. incurred while making online payment of application fees will be borne

by the candidate. Candidates are advised to take a print of the receipt of fee of application form for their records and future reference.

(C) Payment of application fees by any other mode viz Cash, Cheque, Money Orders, Postal Orders, Pay Orders, Banker's Cheques, Postal Stamps, etc., will not be accepted. Such applications will be summarily rejected. The decision of Director, AIIMS Raipur in this regard shall be final and binding.

#### 10. GUIDELINES REGARDING PHOTGRAPHS, SIGNATURES and FORM:

#### (A) <u>Guidelines for scanning the photograph & Signature:</u>

Before applying online a candidate will be required to have a scanned (JPG, JPEG) image of his/her photograph and signature as per the specifications given below:

#### (i) Photograph:

- o Photograph must be recent passport size coloured, preferably white, background.
- o Caps, hats and dark glasses are not allowed. Religious headwear is allowed but it must not cover the face.
- o Dimensions 200 x 230 pixels (preferred)
- o Size of JPG file should be between 80 kb–100 kb essentially
- o Ensure that the size of the scanned image is not more than 100 KB.

#### (ii) Signature:

- o The applicant has to sign on white paper with Black ink pen by the applicant.
- o The signature will be used to put on the Hall Ticket and wherever necessary.
- o If the Applicant's signature on the answer script, at the time of the examination, does not match the signature on the Hall Ticket, the applicant will be disqualified.
- o Dimensions 140 x 60 pixels (preferred)
- Size of file should be between 50 kb 80 kb essentially
- o Ensure that the size of the scanned image is not more than 80 KB.
- (C) While applying online, in the preview of the form, the candidate's Photo and Signature must be clearly visible to candidate, if photo/signature image is small in size or not visible in preview on website, then it means that the photo/signature is not as per the AIIMS prescribed format and your application will be rejected. So, be careful while uploading your photo and signature.
- (D) Applicants must fill all the fields <u>carefully</u> since after submission of online application request for change in any information at any later stage will <u>not</u> be considered.
- (E) Candidate may access the online application portal by clicking on the link mentioned in the official website (www.aiimsraipur.edu.in).
- (F) The candidates are requested to fill the correct details regarding name/age/sex/caste/address/educational qualification and other relevant fields mentioned in the application portal. Candidates are advised to upload the relevant documents/photographs in the desired format only.
- (G) Once the details are correctly filled the candidate may proceed for the fee payment.
- (H) Once a candidate clicks on SUBMIT button, a page containing some important instructions for payment, a Payment Reference Number and a Link to make payment of Application Fee will open. Candidates may please note that unless they make the payment of Application Fee, their application will be treated as INCOMPLETE. Candidates who wants to pay the fee at later stage can use this Payment Reference Number for re-login and making the payment in order to complete his/her Registration.
- (I) Once form is submitted there shall be no provision for making changes in the application form.

## 11. REQUIREMENTS FOR ADMISSION OF OVERSEAS CITIZEN OF INDIA (OCI):

Overseas Citizen of India (OCI) registered under Section 7A of Citizenship Act 1955 are also eligible to appear in PG courses and all terms and conditions for Indian Nationals will be applicable to the candidates. The candidate will submit proof of Registration as OCI under Section 7A of Citizenship Act 1955 to be eligible to appear for this test. This is in addition to conditions laid down in PhD Guidelines 2023 of AIIMS, Raipur.

#### 12. SUBMISSION OF CASTE CERTIFICATE BY SC/ST/OBC CANDIDATES:

After declaration of result of the Entrance Examination, candidates belong to Scheduled Caste/Scheduled Tribe and Other Backward Classes should submit, along with other requisite documents, an attested copy of a certificate from any one of the following authorities stating that the candidate belongs to Scheduled Caste, Scheduled Tribe or Other Backward Classes in the prescribed form.

- A. District Magistrate, Additional District Magistrate, Collector, Deputy Commissioner, Additional Deputy Commissioner, Deputy Collector, 1<sup>st</sup> Class Stipendiary Magistrate, City Magistrate, Sub-Divisional Magistrate, Taluka Magistrate, Executive Magistrate, Extra Assistant Commissioner.
- B. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate.
- C. Revenue Officer not below the rank of Tehsildar.
- D. Sub-Divisional Officer of the area where the candidate and his or her family normally resides.
- E. Administrator/Secretary to Administrator/Development Officer (Lakshadweep Island) or as authorised in the Constitution.

The candidate will be required to submit an undertaking to the effect of their caste. The detection of any discrepancy in the caste certificate shall entail cancellation of registration. This is as per the provisions made by Ministry of Personnel, Public Grievances and Pensions vide their order No. 36033/4/97-Estt. (RES) dated 25.07.2003 and No. 36011/3/2005-Estt. (RES) dated 9.9.2005 respectively.

Candidates must note that a certificate from any other person/authority will not be accepted and no further correspondence in this regard shall be entertained. The name, designation and the seal of the officer should be legible in the certificate.

#### 13. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:
