#### 2. ESSENTIAL QUALIFICATION:

<b>Advanced Diploma in Radiotherapy Technology (ADRT)</b>	Should have passed B.Sc. with the following subjects - Physics, Chemistry and either Biology or Mathematics) with requisite percentage of marks (50% in aggregate for General, OBC and EWS or 45% in aggregate in case of SC/ST Categories). Those candidates who have completed or completing the qualifying examination <b>on or before 31.08.2022</b> are eligible to apply but such candidates must furnish proof of passing the qualifying examination at the time of counselling failing which their candidature will be cancelled.
<b>Pre-Hospital Trauma Technician Course</b>	Having Passed 10+2 with Science - Physics, Chemistry and Biology Subject with minimum 55% marks in the aggregates for General candidates and 50% marks for reserved category candidates. <b>NOTE:-</b> <ol style="list-style-type: none"><li>Those candidates who have completed 10+2 examination <b>on or before 31.08.2022</b>, are eligible to apply but such candidates must furnish proof of passing the qualifying examination with requisite percentage of marks and subjects at the time of counselling failing which their candidature will be cancelled.</li><li><b>Candidates are required to bring all the original documents with one set of photocopies at the time of counselling.</b></li></ol>

No entrance exam will be done for PTT Course. Selection will be made on the basis of aggregate percentage marks of Physics, Chemistry and Biology obtained in 10+2 Examination of CBSE/State Board/any other recognised Board.

### 6. METHOD OF SELECTION

#### For ADRT

Selection to this course will be on the basis of marks scored in written examination only.

#### For PTT

Selection will be made on the basis of aggregate percentage marks of Physics, Chemistry and Biology obtained in 10+2 Examination of CBSE/State Board/any other recognised Board.

### 7. EXAMINATION SCHEME AND SYLLABUS

The Entrance Examination will consist of 100 Objective Type (Multiple Choice and Reason-Assertion type) questions from Physics, Chemistry, Biology or Mathematics and General Knowledge/Aptitude.

The distribution of questions is as follows:



## Advanced Diploma in Radiotherapy Technology (ADRT)

Questions will be based on syllabus of B.Sc. level. There will be no negative marking.

**Note: The examination for above course will be pen-paper based objective type.**

### Pre-Hospital Trauma Technician Course:

No entrance exam will be done for PTT Course. Selection will be made on the basis of aggregate percentage marks of Physics, Chemistry and Biology obtained in 10+2 Examination of CBSE/State Board/any other recognised Board.

## 8. METHOD OF RESOLVING TIES

### Advanced Diploma in Radiotherapy Technology (ADRT)

If two or more candidates obtain equal marks in the entrance examination, then their inter-se-merit for admission to the course shall be determined on the basis of the following:-

1. A candidate who has made more attempts in passing qualifying examination would rank junior to a candidate who has made lesser attempts.
2. If the attempts made in passing the qualifying examination are also the same, then a candidate senior in age will rank senior to the candidate junior in age.

### Pre-Hospital Trauma Technician Course (PTT)

If case two or more candidates have secured same aggregate percentage marks, the inter-se-ranking of such candidates shall be determined by the following order of preferences:

1. The candidates who have secured higher marks in Biology.
2. The candidates who have secured higher marks in Physics.
3. The Candidate who is older in age.

## 9. JOINING

### For ADRT

Selected candidates are required to join on or before 30.09.2022. In case the candidate fails to join by this date and no written request for extension is received by 30.09.2022, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list. Last date for admission to the course will be 31.10.2022. In any circumstances, last date for admission will not be extended after 31.10.2022. This includes candidates on the wait list who may be offered a seat if the selected candidates does not join. No further correspondence will be entertained in this regard.

### For PTT

The information related to date of counselling and joining will be intimated later.

### 13. PROCEDURE TO FILL ONLINE APPLICATION AND PAYMENT OF FEE

- (F) For filling up of online application, candidates must have the following pre-requisites ready:-

- (B) **Guidelines for scanning the photograph & Signature:**

### 14. REQUIREMENTS FOR ADMISSION OF OVERSEAS CITIZEN OF INDIA (OCI)

Overseas Citizen of India (OCI) registered under Section 7A of Citizenship Act 1955 are also eligible to appear in PG courses and all terms and conditions for Indian Nationals will be applicable to the candidates. The candidate will submit proof of Registration as OCI under Section 7A of Citizenship Act 1955 to be eligible to appear for this test.



**15. SUBMISSION OF CASTE CERTIFICATE BY SC/ST/OBC CANDIDATES**

After declaration of result of the Entrance Examination, candidates belong to Scheduled Caste/Scheduled Tribe and Other Backward Classes should submit, along with other requisite documents, an attested copy of a certificate from any one of the following **authorities stating that the candidate belongs to Scheduled Caste, Scheduled Tribe or Other Backward Classes in the prescribed form. (Annexure I, II and III)**

- A. District Magistrate, Additional District Magistrate, Collector, Deputy Commissioner, Additional Deputy Commissioner, Deputy Collector, 1<sup>st</sup> Class Stipendiary Magistrate, City Magistrate, Sub-Divisional Magistrate, Taluka Magistrate, Executive Magistrate, Extra Assistant Commissioner.
- B. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
- C. Revenue Officer not below the rank of Tehsildar.
- D. Sub-Divisional Officer of the area where the candidate and his or her family normally resides.
- E. Administrator/Secretary to Administrator/Development Officer (Lakshadweep Island) or as authorised in the Constitution.

**NOTE:**

1. Candidate applying under SC/ST/OBC(NCL)/EWS/PWBD category, must possess a certificate issued by competent authority (as applicable to category/format provided by AIIMS Raipur).
2. For all purposes Candidate applying under **OBC(NCL)** category, the candidate must possess a certificate issued by competent authority (as applicable to category/format provided by AIIMS Raipur) within one year of last date for Online Registration **20.08.2022 (i.e. issued between 21.08.2021 to 20.08.2022).**
3. OBC candidate will be required to submit declaration in the prescribed format **(Annexure II)** regarding non creamy layer status.
4. EWS certificate should be issued on or after on 01.04.2022 to last date of filling of application form i.e. 20.08.2022 based on the income of year 2021-2022.
5. The detection of any discrepancy in the caste certificate shall entail cancellation of registration. This is as per the provisions made by Ministry of Personnel, Public Grievances and Pensions vide their order No. 36033/4/97-Estt. (RES) dated 25.07.2003 and No. 36011/3/2005-Estt. (RES) dated 9.9.2005 respectively.
6. **Candidates must note that a certificate from any other person/authority will not be accepted and no further correspondence in this regard shall be entertained. The name, designation and the seal of the officer should be legible in the certificate.**

**16. CRITERIA FOR ECONOMICALLY WEAKER SECTION [EWS]**

Reservation for EWS shall be according to the rules of the Government of India. Applicants will be required to produce the necessary certificate in the format provided at the end of the prospectus in support of his/her claim. Certificate to be produced during counselling should be issued on or after on 01.04.2022 to last date of filling of application form i.e. 20.08.2022 based on the income of year 2021-2022.



## 17. REASONS FOR REJECTION/CANCELLATION OF APPLICATION:

APPLICATIONS/CANDIDATURE OF APPLICANTS IS LIABLE TO BE CANCELLED/REJECTED SUMMARILY OR AT ANY STAGE OF THE ADMISSION PROCESS IN THE EVENT OF ALL OR ANY OF THE FOLLOWING:

- i. Applications being incomplete.
- ii. Any variation in the Signatures.  
All the SIGNATURES in FULL (NOT IN SHORT) done on the Print out of the Application Form and also on other Documents must be the same.
- iii. Scanned copy of photograph and signature uploaded are not as per specification given and/or blur or distorted or not clear.
- iv. Non-payment of Examination Fees or non-receipt of fee through online mode, if not otherwise exempted.
- v. Fee not paid as per instructions.
- vi. Under aged/over aged candidates.

## 18. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT
