**I. Important instructions to candidates:**

1. The deputation will be governed by the standard terms and conditions of deputation provided under the DoPT O.M. No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.
2. Maximum age limit for applying for the aforesaid posts on deputation is **56 years** as on the last date of receipt of application, i.e. **19.05.2022**.
3. The period of deputation for all above posts shall not ordinarily exceed **03 years**.
4. **Applications from Non-Government employees will not be entertained.**
5. The Officers who fulfil the prescribed qualifications/eligibility may submit their application form through **online mode** only as per procedure given in this advertisement and take a printout of the same. They are required to **mandatorily send** a duly signed print-out of online application form along with necessary self-attested documents through proper channel to Recruitment Cell, AIIMS Raipur (at address given below) **within 15 days** from the last date of submission of online application failing which candidature of the applicant will not be considered.

They are also requested to ensure that the following documents are enclosed along with the application form being forwarded:-

- (a) Duly attested photocopies of up-to-date Confidential Reports (CRs / APARs) of the latest 05 years of the officer concerned (applicant).
  - (b) Vigilance Clearance Certificate clearly stating that no vigilance/disciplinary proceedings are pending or contemplated against the candidate concerned.
  - (c) No Objection Certificate.
11. Applications without forwarding through proper channel, vigilance clearance and complete APARs / CR Dossiers will not be considered. **However, eligible and interested applicants may send their advance copy of application to the above mentioned address.**

## **II. Procedure for filling up 'Online Application':**

1. For filling up of online application form, candidates must have the following pre-requisites readily available with them:-
  - (a) Valid e-mail ID.
  - (b) Scanned passport size photograph of the candidate (in JPEG/JPG format).
  - (c) Scanned signature of the candidate (in JPEG/JPG format).
  - (d) Online payment detail for payment of the required application fee.
  - (e) Specification and size of image files (scanned copy of photograph and signature of the candidate) should be as per the details given below.
2. Candidates have to go to the online application portal given on the website of AIIMS Raipur ([www.aiimsraipur.edu.in](http://www.aiimsraipur.edu.in)), register themselves and follow the instructions on the application portal for filling up online application form.
3. Candidates must fill all the fields of the online application form **correctly** as after submission of online application, request for change in any information at later stage will **not** be considered.
4. While applying online, candidates must ensure that in the preview of online application form, their photo and signature are clearly visible. If in the preview image is small in size or not clearly visible that means that the image file of photo or /and signature is not as per the prescribed specifications. It will lead to rejection of application. Hence, candidates are advised to adhere to the specifications of image.
