The complete Electrical services has not been commissioned so far, hence rates approved as per BoQ item could not be operated due to non-commissioning of entire system and any supplementary agreement is also not available in this regard. There is no approved rates are available for partial work which have been completed and Operation and Maintenance work is going on, Prevailing system on the basis of bill claimed by M/s Ahluwalia Contracts (I) Ltd. which is being allowed as actual man months bill system is not covered under the ongoing contract. More over in the prevailing system reckoning of dates of DLP and 1st, 2nd, 3rd, 4th, 5th, and 6th Year after taking over is varied for each equipment/work, which may be critical.

In spite of non-availability of any supplementary agreement, contractor stated that rates of operation & maintenance of electrical equipment's, which was partially commissioned, had been mutually agreed with Project Cell as per contract agreement, but no document is available.

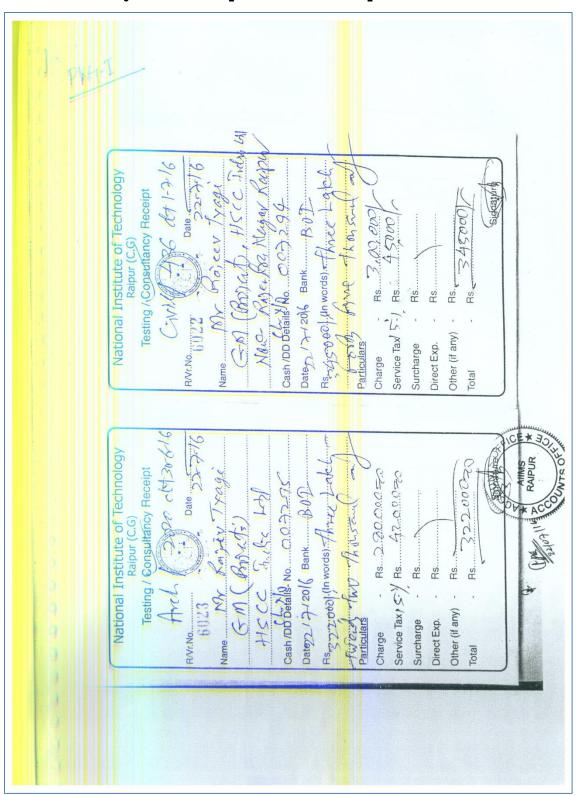
