



MINUTES OF THE MEETING

Subject: Minutes of the Meeting of the Committee constituted for assessment and evaluation of applications received for empanelment of Advocates/Law Firms for AIIMS Raipur

Date: 26 December 2025

Venue: Chamber of the Senior Administrative Officer, AIIMS Raipur

A Committee constituted by the Competent Authority met on the above-mentioned date to assess and evaluate the applications received for empanelment of Advocates/Law Firms for representing AIIMS Raipur before various judicial and quasi-judicial forums.

The Committee examined the information furnished by the applicants in the empanelment forms along with the supporting documents submitted by each Advocate/Law Firm. A comparative chart was prepared and placed before the Committee (Annexure-I).

After detailed scrutiny of documents and deliberations, the Committee unanimously resolved to adopt the following minimum eligibility criteria for empanelment:

A. For handling the cases before Hon'ble Supreme Court of India:

Minimum **05 (five) years** of professional experience in Hon'ble Supreme Court cases.

B. For handling the cases before Hon'ble High Court:

Minimum **05 (five) years** of professional experience in Hon'ble High Court cases.

C. For handling the cases before Hon'ble District Court & Tribunals:

Minimum **03 (three) years** of professional experience.

D. For handling Arbitration & CAT cases before Hon'ble Appropriate Court:

Minimum 05 (Five) years of professional experience.

Professional experience ranging from a minimum of 03 (five) years shall be required for selection.

Based on the above criteria and verification of records, the Committee recommended preparation of a category-wise provisional empanelment list, as detailed below:

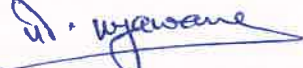

The competent authority of AIIMS, Raipur shall after considering the representation received within the stipulated time publish the final list of empanelment of Advocates / Law Firms.

The Committee has also recommended to renew the empanelment of the Advocates / Law Firms which were already empanelled for AIIMS, Raipur, as they have expressed their willingness.
