
**Annexure-I**

**BCR-ABL1 Mutation Detection Kit Specifications**

1. The kit should be a real-time Polymerase Chain Reaction (PCR) assay kit for the of BCR-ABL mutation in the genomic DNA extracted from bone marrow or peripheral blood samples.
2. Kit should be compatible with Real Time PCR instruments like Himedia Insta Q96 Model-LA1073.
3. Application support related to the kit like setting up assay, running tests, standardizing the protocol and analysis and interpretation of the result to be provided by the manufacturer company/brand.
4. The Kit should have a min. expiry of 1year.
5. The kit should be based on ARMS PCR technology.
6. The Kit should be able to detect specific mutations of MMR, MR4, and MR4.5 status reporting.
7. The kits should provide reagents optimized for reliable and sensitive detection and quantitation of BCR-ABL p210 b2a2 or b3a2 transcripts, relative to ABL control gene expression.
8. The results should be directly aligned on the International Scale (IS).
9. There should be an IS-MMR calibrator aligned with World Health Organization's (WHO) reference material to prevent intra- and inter-lab variation in every run.
10. This should have high reliability using EAC technology and single plasmid standards.
11. Assay must be very sensitive to detect up to 0.2 % mutation.
12. The kit should needed Ready-to-use solutions including all reagents for RT and qPCR.
13. Kit should be CE-IVD / US-FDA approved.
14. LOD should be around 0.0069.

**Additional terms & conditions**

1. Supplier must provide technical support in person on site within 48 hrs. of lodging the complaint.
2. Supplier will have to set up the kits/ reagents on site at AIIMS Raipur within 7-15 days after the delivery of consignment.
