Technical Specification of Chlamydia Trachomatis Detection RT- PCR Kit, Gonorrhoea RT-PCR kit and Syphilis Detection RT-PCR

1. The kit should be TaqMan chemistry based single tube multiplex kit.
2. The specificity should be equal to or more than 99%.
3. The Kit should be stable upto 5 repeated freezing/thawing cycles.
4. The kit should have exogenous internal control.
5. The kit should be IVD approved.
6. The literature of kit should be in English.
7. The kit should be compatible for all nucleic acid extraction kits.
8. Single-tube Multiplex Kit will be preferred.

2. The kit should be TaqMan chemistry based multiplex kit.
3. The Kit should be stable upto 05 repeated freezing/thawing cycles
4. The kit should be compatible for all nucleic acid extraction kits.
5. The literature of kit should be in English and available on company website.
6. The specificity should be equal to or more than 99%.
7. The kit should be able to detect both HSV-1 & HSV-2 individually in a single tube.
8. The limit of detection should be equal to or less than 30 copies/reaction.
9. The kit should have exogenous internal control.
