

RT-PCR Kit Specification for Respiratory Panel

1. The kit should have respiratory viral coverage of following viruses: Respiratory Syncytial Virus A and B, Influenza A and B, Human Metapneumovirus A and B, Enterovirus, Rhinovirus, Human Parainfluenza 1,2,3 and 4, SARS-COV2, Human Adenovirus.
2. The kit should have respiratory bacterial coverage of following viruses: Chlamydia pneumoniae, Haemophilus influenzae B, Staphylococcus aureus, Legionella pneumophila, Pneumocystis jirovecii, Salmonella sp., Haemophilus influenzae, Klebsiella pneumoniae, Streptococcus pneumoniae, and Mycobacterium tuberculosis.
3. The Kit should be TaqMan chemistry-based kit and able to be performed in 1-7 tubes.
4. The specificity should be equal to or more than 99%.
5. The limit of detection should be equal to or less than 50 IU/mL.
6. The Kit should be stable upto 5 repeated freezing/thawing cycles.
7. The kit should have endogenous internal control.
8. The kit should be CDSCO and IVD CE approved.
9. The literature of kit should be in English and available on company website.
10. The kit should be compatible for all nucleic acid extraction kits.
11. The bulk order will be placed after satisfactory performance of sample kit or supplied kit in “**Lot to Lot verification**” process.
12. A list of INIs using the product should also be preferably attached.
