- 1. The kit should be a real-time polymerase chain reaction (PCR) assay kit for detecting EGFR somatic mutations in the genomic DNA extracted from fresh, frozen or formalin fixed paraffin-embedded (FFPE) tissue or liquid biopsy.
- 2. The kit should be based on ARMS PCR.
- 3. Kit should be compatible with Real Time PCR instruments like Himedia Insta Q96 Model-LA1073.
- 4. Application support related to the kit like setting up assay, running tests, standardizing the protocol and analysis and interpretation of the result to be provided by the manufacturer company/brand.
- 5. Kit should have a min. expiry of 1 year.
