SPECIFICATION FOR BRONCHOSCOPE DRYING & STORAGE UNIT

1. The cabinet must have facility for aseptic either vertical or horizontal drying or storage of flexible bronchoscope without touching each other.
2. Must be compatible with bronchoscope and pleuroscope of any brand.
3. The cabinet must have capacity to store at least six scopes.
4. Must have in built HEPA filter or Air Filter of 1 micron or less for the air filtering. In- Built in air compressor and fan to maintain sufficient flow rates between scopes.
5. Ultra violet ray facility is optional.
6. There must be sufficient gap between two scope for easy access
7. Body of cabinet and interior must be made of stainless steel, corrosion resistant and compatible with the Indian climatic condition.
8. Interior and exterior of the cabinet must be free of sharp and pointed edges to avoid damage to scopes.
9. The power supply for the cabinet must be compatible for the Indian standard
10. Must have independent connector for drying each scope
11. Must be supplied with all essential accessories to make the unit functional
12. Should have BIS/US FDA/European CE certified.
13. Onsite warranty for 5 years.
14. Service must be provided within 7 days of registration of complaint, failing which penalty will be imposed as per the rule.
