- 3. Should be made of powerful piston compressor motor.
- 4. To protect any electrical damage nebulizer must be equipped with safety fuse inside.
- 5. Appropriate particle size of MMAD between 3µm and 5µm
- 6. Should be able to run uninterrupted for one hours max pressure 2-2.5 bar (Approx.)
- 7. Low noise operation < 60 dB.
- 8. Protective thermal cut out relay if overheated.
- 9. Supplied with- CHILD MASK, ADULT MASK, AIR TUBE, at least 2 AIR FILTERS and other standard accessories.
- 10. Air deliver rate approx. 5-15L/min.
- 11. Onsite Warranty- 02 Year on whole product including replacement of Motor (Against any kind of defect) and other Parts.
- 12. Price of Motor, front and back cover, and other spares should be fixed for product Life span or product life time.
- 13. Unit should be portable and table top.
- 14. Certification of product- ISO/BIS/CE (Whichever is applicable).
