12. Payment Clause:

100% Payment shall be made subject to recoveries, if any, by way of liquidated damages or any other charges as per terms & conditions of contract on receipt of goods in good condition/fitting (installation) at the consignee premises and upon the submission of the following documents:

14. Fall Clause:

- 1. Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he bids to sell or sells the stores of identical description to any other State Government/DGS&D/Public Undertaking during the period of the contract.
- 2. If at any time during the period of contract, the prices of tendered items is reduced or brought down by any law or Act of the Central of State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing authority will revise the rates on lower side. Any deviation in the material and the specifications from the accepted terms may liable to be rejected and the suppliers need to supply all the goods in the specified form to the satisfaction/ specifications specified in the Purchase order and demonstrate at the their own cost.

15. Arbitration:

If any difference arises concerning this agreement, its interpretation on payment to the made there under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the Director, AIIMS Raipur to settle the dispute by Sole Arbitrator. Sole arbitrator will be appointed by the Director, AIIMS Raipur. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.

16. Legal Jurisdiction:

The agreement shall be deemed to have been concluded in Raipur, Chhattisgarh and all obligations hereunder shall be deemed to be located at Raipur, Chhattisgarh and Court within Raipur, Chhattisgarh will have Jurisdiction to the exclusion of other courts.

- 17. 1. Specification of Breast Examination Trainer.

The Breast Examination Trainer should be highly realistic learning platform for acquiring the skills required to perform Clinical Breast Examination (CBE) having features readily interchangeable and multi-positional pathologies, providing healthcare professionals with the tools to identify various complications and pathologies including carcinomas, cysts, fibrocystic disease and fibro adenoma.

2. Specification of Obstetrics Examination Trainer.

The simulator allows you to practice antenatal diagnostic methods, including Leopold's techniques, fetal auscultation and pelvimetry.
