

Page No. 5 Earnest Money Clause	<p><b>Earnest money</b></p> <p>a. As to invite wider participation, earnest money ₹ 30,00,000.00 of by means of a Bank Demand Draft/ FDR, a scanned copy to be enclosed. It is also clarified that the bids submitted without earnest money will be summarily rejected. The DD/FD may be prepared in the name of "All India Institute of Medical Sciences, Raipur (AIIMS RAIPUR)". The used instrument must reach at officer of the Hospital Store Office, Room No. 146, Near Department of Nuclear Medicine, C-C1 Block, Gate no.1, Tatibandh, Raipur (C.G) Pin- 492099 before opening of tender.</p> <p>b. No request for transfer of any pervious deposit of earnest money or security deposit or payment of any pending bill held by the AIIMS Raipur in respect of any previous supply will be entertained. Tenderer shall not be permitted to withdraw his bid or modify the terms and conditions thereof. In case the tenderer fail to observe and comply with stipulations made hereinor backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.</p> <p>i. Tenders without Earnest Money will be summarily rejected.</p> <p>ii. No claim shall lie against the AIIMS Raipur in respect of erosion in the value or interest on the amount of EMD.</p> <p>iii. The bidder seeking EMD Exemption must submit the valid supporting document for the relevant category as per tender document. Under MSE (Micro &amp; Small Enterprises) category, only manufacturers for goods and service providers for services are eligible for exemption from EMD. Traders are excluded from the purview of this policy.</p> <p>iv. The earnest money will be returned/refund to the unsuccessful tenderers after the tender is decided.</p> <p>v. EMD should remain valid for a period of 45 days beyond the final bid validity period.
