Candidate should bring one set of self- attested xerox copy of all relevant certificates photocopies of duly filled application form (As per the prescribed Performa) and all original certificates of educational qualifications, and experience certificate, identity proof, along with two photographs and set of self-attested photocopies of all certificates and relevant documents at the time of interview.

- 8. Candidate has to join within one week of declaration of result.
- 9. Any attempt to unduly influence the selection process will lead to automatic dis-qualification of the applicant.
- 10. Shortlisting & selection of candidates and final selection will be purely on merit basis which will be finalized by the scrutiny and selection committee and their decision will be final.

- 12. Final selection will be purely on a merit basis which will be finalized by the selection committee and their decision will be final.

#### 2. Terms and Conditions:

- 1.1 It is candidate's responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. Any misinformation detected at any stage will make the candidate disqualified and liable for legal action. Permission to appear in the selection process does not approve the eligibility of the candidate. Even after qualifying the selection process the candidate may be rendered disqualified at the time of document verification if he / she does not fulfil essential eligibility criteria.
- 1.2 The selection will not be an employment on AIIMS Raipur or UNICEF pay-roll. Employment will automatically terminate upon completion of the tenure mentioned from the day of joining of duties and there is no liability for permanent employment in AIIMS, Raipur or Programme Director. Also, the candidates have no right to claim permanent employment in AIIMS Raipur or UNICEF,NHM based on this job.
- 1.3 Employment of selected candidates will automatically terminate upon completion of contract.
- 1.4 Selected candidates have to complete their probation period of 3 months initially from the date of joining and after completion of probation period, candidates' tenure will be extended for further period. Extension of tenure after probation period will purely depend upon the candidate satisfactory performance which will be scrutinized by the Programme Director.
- 1.5 The contract can however be extended depending on the candidate's satisfactory performance and budget grant from the funding agency and continuing requirements for the position.



- 1.6 The candidate who is already in Government service shall submit 'No Objection Certificate' from the present employer at the time of interview.
- 1.7 Record of this recruitment will be preserved for the period of six months from the date of declaration of the result after the completion of the above period all documents related to this recruitment will stand destroyed.
- 1.8 <u>Tenure:</u> The assignments are purely on contract basis for the period starting from or early based on selection process date of joining to 31 December 2024 after completion of probation period. This appointment will not vest any right to claim by the candidate for regular appointment or Permanent absorption in AIIMS Raipur or UNICEF or for continued contractual appointment.
- 1.9 Expiry of Contract: The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
- 1.10 Accommodation: No hostel or any other accommodation will be provided by the Institute for attending the interview at any stage of recruitment.
- 1.11 Leave rule: Candidate will be entitled for 15 leave (inclusive of all leaves medical, casual& others during the I year contract period) for 1 year starting from 01 January 2024 to 31 December 2024 on pro-rate basis. Leave encashment and carryover of leave for tenure will be not admissible.
- 1.12 Canvassing of any kind will lead to disqualification.
- 1.13 Private practice of any type is prohibited.
- 1.14 Candidate is expected to confirm to the rules of conduct and discipline as applicable to the institute employees.
- 1.15 The decision of the competent authority regarding the selection of the candidate will be final and no representation will be entertained in this regard.
- 1.16 The candidate should not have been convicted by any Court of Law.

Name of the position -IMSAM Project Coordinator

Purpose of the post:Project Coordinator shall report to the Nodal Person in charge (Project Director) of State Center of Excellence for Nutrition (SCoE4N) at, Department of Pediatrics, AIIMS, Raipur and shall be responsible for providing support in capacity building, monitoring and knowledge management under the SCoE for strengthening the Facility and Community-based management of SAM in Chhattisgarh State. Technical oversight and funding for the position shall be provided by a respected International Development Agency that works across the globe, to promote children's survival, protection and development.

## Major duties and responsibilities:

- To look after the overall coordination and functioning of the State Center of Excellence for Nutrition, AIIMS, Raipur.
- Provide techno-managerial support for conducting phase-wise training programs for medical officers and Feeding Demonstrators, staff nurses & other staffof all NRC personnel on SOPs for the management of non-responders/critical cases of children with SAM.
- Support for the establishment of SMART (State of Art 'Severe Acute Malnutrition Referral & Advance Treatment' unit
- Provide techno-managerial support to the SMART unit and Tele mentoring unit housed in AIIMS Raipur
- Provide support in inter-departmental coordination between DWCD and DoHFW/ NHM and Medical Colleges for convergent activities under the SCoE.
- Provide support in establishing supportive supervision mechanism in coordination with NHM, DWCD
  and stakeholders along with capacity building, data analysis & review of findings and recommendations
  to the state department.
- Provide techno-managerial support to various operational research/ pilot studies conducted under, Dept. of Pediatrics, AIIMS Raipur
- Rapid assessment support to NRCs in Chhattisgarh state on a sample basis, through the already developed NRC assessment checklist.
- Accreditation of NRCs in Chhattisgarh state in coordination with NHM and UNICEF.
- Provide support in the documentation of best practices followed at SMTUs, NRCs and community and develop resource materials, as required from time to time.
- Facilitate inter-departmental coordination and convergence between DWCD, NHM, Education dept and other line departments and AIIMS Raipur including other development partners to improve implementation of Integrated Management of SAM in Chhattisgarh state.
- Facilitate data analysis and biannual review meetings at the state level with key departments and CoE,
   AIIMS Raipur, to review the program indicators for CSAM with a focus on sharing bottlenecks identified in supply chain, record keeping, reporting and data validation and communication plan implementation.
- Coordinate monthly/quarterly review meetings at to discuss the findings, gap assessments, data issues and scope for improvement.
- Provide support in documentation / developing progress reports and sharing of best practices/success stories in CSAM and AMB program at community and develop resource materials, as required from time to time.
- Compile and share all field visit trip reports with the Nodal Person for CSAM/AMB and government counterparts.
- Maintaining and sharing records of trainings held, participant's details, meeting minutes, financial records, and other administrative support to the department for CSAM and AMB programs.




- Facilitate coordination with finance department/research cell/Director's cell of AIIMS for smooth and timely functioning.
