- Experience Certificate: It should clearly state the nature of work during the period of employment. Experience should have been gained after acquiring the minimum essential qualification.

Document Verification: At the time of joining duty, candidates should bring all original certificates of educational qualifications, Adhar card, Objection Certificate (NOC) from the present employer, experience certificates, and two passport photos, other relevant certificate (if applicable) along with one set of xerox.
- 20. The recruited project staff is eligible for leave as per project recruitment rules and will have to give undertaking before joining.
