**ADVERTISEMENT FOR ENGAGEMENT OF 'MEDICAL PHYSICIST' PURELY
ON CONTRACTUAL BASIS FOR THE DEPARTMENT OF NUCLEAR
MEDICINE AT AIIMS RAIPUR**

AIIMS Raipur is an apex healthcare institute, established by the Ministry of Health and Family Welfare, Government of India under the Pradhan Mantri Swasthya Suraksha Yojna (PMSSY) with the aim of correcting regional imbalances in quality tertiary level healthcare in the country and attaining self-sufficiency in graduate and postgraduate medical education and training.

Executive Director and CEO, AIIMS Raipur invites application from the Indian Nationals in the prescribed format available on the website of AIIMS Raipur (www.aiimsraipur.edu.in) for engagement of '**Medical Physicist**' in the Department of Nuclear Medicine at AIIMS Raipur **on contractual basis for a period of 11 months**. The detailed eligibility criteria for the post are as follows:-

Age limit	Up to 40 years

Terms & Conditions for applying under reserved category:

1. Age and all other qualifications will be counted as on last date of application.
2. The above vacancies are provisional and subject to variation. The Executive Director, AIIMS, Raipur reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements of the Institute.
3. The reservation and relaxation applicable to various categories will be admissible as per the Govt. of India Rules on production of valid caste/category certificate in the prescribed format.
4. The reservation for ST/SC/OBC/EWS candidates is as per Central Govt. rules and 4% reservation for PwBD candidates (on horizontal basis). For OBC Candidate, candidates must attach certificate valid for the posts under the Central Government of India which mentions that the Candidate does not belong to Creamy Layer. Date of issue of Certificate should be in the vacancy year. For

- SC, ST and OBC, Certificate should be issued by Tehsildar or above rank authorities prescribed by the Govt. of India in the format prescribed by the Central Govt.
5. For posts reserved for OBC category, OBC-NCL candidates' eligibility will be based on the castes borne in the Central List of Govt of India. The OBC candidates applying for the vacancies reserved for them against this advertisement must produce OBC (Non-Creamy Layer) certificate based on the income for the Financial Year (FY) 2026-27, based on income up to the financial year ending on 31.03.2026, and should be issued on or after 01.04.2026 and up to the closing date of application, i.e. 12.08.2026.
 6. EWS certificate issued in prescribed format for employment in Central Government on the basis of income of financial year 2025-2026 issued from 01.04.2026 to 12.08.2026 valid for the financial year 2026-2027 will be considered valid. (format given in the DoPT O.M. dated 31.01.2019).
 7. Reservation/relaxation to Person with Benchmark Disabilities (PwBD) will be admissible in accordance with the PwD Act, 2016 and the Ministry of Social Justice and Empowerment, Govt. of India, Notification No. 38-16/2020-DD-III dated 04.01.2021 as amended from time to time on submission of valid Disability Certificate. The Institute may verify the authenticity of the certificate of disability and examine suitability of the candidate in terms of functional requirements before appointment against any identified post. In this regard, the decision of Competent Authority at AIIMS Raipur will be final.
 8. Ex-servicemen/Commissioned Officers seeking age relaxation shall be required to produce Discharge Book / documents issued by the competent authority in support of their category.
 9. As per the Govt. of India rules, EWS posts will not be carried forward to next year as backlog vacancy in case unfilled. Hence, **other category candidates (i.e. UR/OBC/SC/ST) are allowed provisionally to apply** for such posts subject to condition that they will be considered for such post as a UR Candidate.

Important Instructions to Candidates

1. **Application Process:** Advertisement along with application form in the prescribed format is available on the website of AIIMS Raipur (www.aiimsraipur.edu.in). The print-out of duly filled in application form (**Annexure-I**) along with a self-attested photocopy of all relevant certificates relating to age, educational qualifications, experience etc. with a colored passport size photograph should be sent through Speed-Post/Registered Post, to the following address on or before 10-08-2026, 5:00 pm. Applications received after the last date is liable to be rejected. The Institute shall not be responsible for any postal delay. No correspondence in this regard shall be entertained. 3. The applicants applying for above post in response to this advertisement should satisfy themselves regarding their eligibility for the post and must fulfil all the eligibility criteria on or before the last date of application i.e. **12-08-2026**, failing which their application will be rejected.

5. **NOC from Present Employer:** Persons working in the Govt./Semi-Govt. Organizations/ Corporations/Autonomous Institutes/PSUs etc. are required to submit NOC from their present employer along with their application form.
6. No TA/DA will be paid for appearing in the interview.

Scheme of Selection

Final selection for Medical Physicist shall be carried out based solely on the basis of marks obtained in the interview. **The date of Interview shall be published on the website of the Institute in due course. No separate intimation will be issued to candidates.**

Terms & Conditions for Appointment on contract basis at AIIMS Raipur

1. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
2. Canvassing of any kind will lead to disqualification.
3. The appointment is purely on contract basis for a period of 11 (eleven) months or till such time an alternate arrangement is made, whichever is earlier, with effect from the date of joining. As per the requirement of the Institute, the period of contract may be extended for another term or for a specified period, whichever is less, subject to satisfactory performance of the incumbents and approval of the competent authority. If the contract is not extended further, the same will lapse automatically.
4. The appointment can also be terminated at any time, on either side, by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of competent authority.
5. The appointee shall be on the whole time appointment of the AIIMS Raipur and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
6. The appointee is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
7. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
8. If an appointee wishes to apply somewhere else or resign within the first 03 (three) months of joining, then neither he/she will be issued a 'No Objection Certificate' nor he/she will receive any Relieving Letter or Experience Certificate.
9. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
10. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty / staff members of AIIMS Raipur.
11. The appointee shall not be granted any claim or right for regular appointment to any post at AIIMS Raipur. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS Raipur.
12. The candidate should not have been convicted by any Court of Law.

13. In case of any information given or declaration made by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to this appointment, he/she will be liable to be removed from the service and any other action taken as deemed fit by the appointing authority.
14. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
15. The Director, AIIMS Raipur reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
16. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issue of appointment letter, the Institute reserves the right to modify/cancel any communication made to the candidate.
17. The appointee is not entitled to any TA/DA for attending the interview and joining the service on selection/appointment.
18. Other conditions of service will be governed by relevant rules and orders issued from time to time.
19. If any declaration given or information furnished by candidates found false or if he/she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Institute may deem necessary.
20. The appointment to the said post will be subject to medical fitness from the competent medical board.
